

TRAVEL AND EXPENSE POLICY

Purpose:

1. The purpose of this policy is to establish criteria for the reimbursement of expenses.

General Travel Expenses:

- 2. Board members, coaches or meet officials who travel for any meeting or event where they
- a) represent on behalf of the club (e.g. annual general meetings, symposiums and meets but excluding practices), and
- b) travel greater than 50 km from the town of residency to the meeting or event

will be reimbursed at a pre-approved mileage vehicle mileage rate of \$0.40/km, or for the cost of travel tickets purchased to attend the meeting or event.

Coaches:

- 3. In addition to general travel expenses, KWSSSC will reimburse the pre-approved expenses listed below, to accommodate up to two coaches per meet.
- 4. KWSSSC will not be obligated to send a coach to every meet that has a club skater(s).
- 5. KWSSSC requires expenses to be paid initially by the coach and will reimburse those expenses by club cheque upon receipt of itemized invoice(s).
- 6. Pre-Approved Expenses are:
 - a) Hotel Accommodations:
 - 1 night for out of town meets that are 1 day and further than 100 km from the town of residency of the coach
 - 2 nights for out of town meets that are 2 days and further than 100 km from the town of residency of the coach
 - b) Meals:
 - For a 1 day meet, no meals are reimbursable unless the meet is further than 100 km from the town of residency of the coach, in which case 1 dinner (without alcohol) is reimbursable to a limit of \$30.
 - For a 2 day meet, 2 dinners (without alcohol) are reimbursable if the meet if further than 100 km from the town of residency of the coach, to a limit of \$30 per meal.
 - c) Other:
 - KWSSSC will pay the coaches' registration fee for coaching clinics. The club will annually pre-approve the number of coaches that will attend these clinics, with an

- expectation from those coaches that they will commit to coach at the club for a minimum of 2 years after the clinics are paid for.
- Coaches who do not fulfill this 2-year commitment will be expected to reimburse KWSSC for 50% of the cost of the clinics.
- KWSSSC will support coverage of coaches' National meet expenses. The club will annually review the reimbursement amounts based on the meets the coach(es) attended for the year.

Meet Officials:

- 7. KWSSSC will provide funds for official upgrading for all levels.
- 8. KWSSSC will pay registration fees for any club official who attends events representing our club as a meet official (eq. Officials symposiums, conferences etc.)

Club Purchases:

- 9. KWSSSC will require reimburse the cost of approved purchases by club cheque upon receiving an itemized receipt.
- KWSSSC will require approval by the Board of Directors before the purchase is made for non-routine purchases exceeding \$50.

Other:

- 11. All requests outside of pre-approved expenses for mileage and coaching **must be**presented to and discussed by the Board of Directors pending any approval and the
 Board reserves the right to accept or deny any request.
- 12. Payment of an expense by a member does not automatically mean the club will reimburse the expenditure.

Review

13. This policy will be reviewed annually, or as decided by the KWSSSC Board of Directors.

Approval
